I, SI Kamallesh Joarder of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e 31.05.2021 at 21.05 hrs I received specific source information that two person would be coming from Sahudangi side with contraband drugs containing in two bag for disposing the same at New Jalpaiguri area. I accordingly shared the information through messenger to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate and as per his kind direction, diarized the fact in GD vide New Jalpaiguri PS GDE No 1378 Dated 31.05.2021. Consequently, at 21.15 hrs, myself along with NVF 0064 P. Roy, CV 460 S. Mandal both of NJP PS, SPC, SI Mrityunjoy Roy, C/945 Krishna Barman, C/932 Pabitra Das, C/1054 Arabinda Roy, C/598 Shibu Das of DD, SPC, all left for Gora More to verify the veracity of the information vide GDE No 1378 dated 31.05.2021 by Govt. Vehicle taking necessary articles like white paper, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 21.35 hrs we reached near Gora more and parked the vehicle at considerable distance and proceeded towards Gora more Meanwhile, I called two disinterested witnesses
