**Subject: Request to lodge F.I.R against Mr Riyaz Mollah ( Name as declared by him)**

Sir,

With due respect, I would like to inform you that the residents have been reporting incidents of theft of various parts of Fire Hydrant systems ( Couplings, Nozzles, manual Valves etc.) installed in all the Building of our residential society namely SHANTINIKETAN HOUSING SOCIETY.

The premises is covered by CCTV cameras as well as manned by security personnel 24\*7. Post receipt of complaints, the CCTV cameras were analysed and the security staffs were kept on alert. Subsequently, the vigilant security staff has caught the above named person namely Mr Riyaz Mollah who was working as mason to undertake repair of external walls, red handed, along with 03 pieces of the stolen materials.

It is relevant to mention that a total of 141 nos. parts of the Fire Hydrant system comprising of different units have been found to be missing. When caught, the said person namely Mr Riyaz Mollah has confessed to the stealing of all the missing parts (141 nos.). The accused person was handed over to the Police. The total cost of the stolen parts is estimated to be **Rs 6, 50,000/- ( Six Lakhs fifty thousand only)**.

It is pertinent that the Fire Hydrant systems are an essential part of the residential society, which is kept operationally ready to meet any fire emergency. Availability of the missing parts is required on urgent basis to keep the system operational to avoid any kind of fire hazard scenario.

In view of the above, it is requested that a First Information Report may be registered against the accused person namely Mr Riyaz Mollah and needful be done in accordance with the law to recover the stolen parts ( 141 pieces).
