Sir,

I, ASI Ratan Pradhan of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Raju Saha (31), S/O- Lt Dilip Saha of Dhaknikata, Champasari, P.S.- Pradhan nagar, Dist- Darjeeling along with i) 17 (Seventeen) bottles of Himalayan Gold 60up Country Spirit containing 300ml each, ii) 10 (Ten) pouches of Officer's Choice Delux Whisky contains 180 ml each, which has been seized under proper seizure list (enclosed herewith), to the effect that on 31.05.2021 at 20.45 hrs I received a secret source information that one person namely Raju Saha is storing and selling illegal liquor from his house at Dhaknikata. Accordingly I informed the matter to the I/C Pradhan nagar PS, SPC and as per his kind direction myself along with ASI Debasish Das, ASI Ashit Singha, CV 131 Ranjan Sharma, CV 128 Ajay Kumar sahani, CV 223 Sapan Cheetri all of Pradhan nagar P.S. left for Dhaknikata to verify the veracity of the source information vide Pradhan nagar P.S. GDE No 1761, Dated 31.05.2021 at 20.55 hrs. On reaching at the spot at 21.10 hrs and after being confirmed by the sources, I apprehended one person namely Raju Saha. On interrogation it was learnt that since a long time he was running this illegal business of selling illegal liquors to public, without any document or valid license for his illegal gain. Accordingly, search has been conducted and from inside the stall cabin I recovered i) 17 (Seventeen) bottles of Himalayan Gold 60up Country Spirit containing 300ml each, ii) 10 (Ten) pouches of Officer's Choice Delux Whisky contains 180 ml each. On demand said Raju Saha failed to produce any such document in respect of recovered liquors. It is a violation under Bengal Excise Act. I accordingly seized the said liquors from the apprehended person, under proper seizure List duly signed by them and the witnesses. This seizure was made in between 21.35 hrs to 22.15 hrs. Accordingly I arrested the accused person Raju Saha (31), S/O- Lt Dilip Saha of Dhaknikata, Champasari, P.S.- Pradhan nagar, Dist- Darjeeling, after preparing memo of arrest and intimating the ground of arrest. At 22.35 hrs the arrested accused person along with seized articles has taken to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Raju Saha (31), S/O- Lt Dilip Saha of Dhaknikata, Champasari, P.S.- Pradhan nagar, Dist- Darjeeling and arrange for it's investigation.
