Gangadhar Das of Debasish Colony, Fuleswari, South Bharat Nagar, PS- Siliguri, Dist- Darjeeling, (iv) Mainul Haque (37) s/o- Mojamil Haque of Paschim Dhantola, Fulbari near Satelighat Township, PS- NJP, Dist. Jalpaiguri, (v) Chittaranjan Das (61) s/o- Lt. Meghlal Das of Prankrisna Colony near SIB office, W/No- 28, PS- Siliguri, Dist- Darjeeling, (vi) Raju Biswas (18) s/o- Nilratan Biswas of Chittaranjan Colony near Shiv Mandir, W/No- 20, PS- Siliguri, Dist- Darjeeling, (vii) Sonu Singh (28) years s/o- Sharup Singh of Ambika nagar near Ambika Nagar Sporting Club, PS- NJP, Dist. Jalpaiguri alongwith their vehicles viz- (i) One blue colour TOTO without number plate, (ii) One white colour TOTO without number plate, (iii) One green colour TOTO without number plate, (iv) One yellow colour TOTO without number plate, (v) One red colour TOTO without number plate and (vi) One red colour TOTO having registration No- WB-71/978. I SI Swapan Basu Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 30.05.2021 at 10.05 hrs during my R/T Mobile Van duty had been to Venus More, Siliguri and found the above noted persons were gathered/ roaming there along with their respective vehicles noted above without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
