In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Amit Gupta (32) years s/o- Shambhu Prasad Gupta of Champasari main Road, Sawannagar near SBI, PS- Pradhannagar, Dist. Darjeeling, (ii) Gopal Das (40 yrs) s/o- Lt. Rano Charan Das of Tikiapara, 2 No. Matangini Colony, W/No- 28, PS- Siliguri, Dist- Darjeeling, (iii) Rahul Garg (28 years) s/o- Subhas Garg of Khalpara near Agrasen Bhawan, W/No- 9, PS- Siliguri, Dist- Darjeeling, (iv) Arun Mahto (30 years) s/o- Binda Mahato of H.C Road near Panna Sweet, W/No- 06, PS- Siliguri, Dist- Darjeeling, (v) Rajesh Kumar Singh (26 year) s/o- Manoj Singh of Azimganj City Bin para, PS- Giaganj, Dist- Mursidabad, (vi) Smt. Taposhi Mahanta (26 years) w/o- Babu Mahanta of Bhabesh More near Bhabesh Patrol pump, PS- NJP, Dist. Jalpaiguri, (vii) Uttam Bhadra (31 years) s/o- Ratan Bhadra of Baghajotin Colony, W/No- 45 near Baghajotin Bidyapith, PS- Pradhannagar, Dist. Darjeeling and (viii) Aditya Mahanta (28 years) s/o- Sukdeb Mahato of Baribhasa, Kamapara near Samar Biri Factory, PS- Bhaktinagar, Dist- Jalpaiguri were alongwith two sky colour TOTO without number plate. I SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 30.05.2021 at 10.15 hrs during my R/T Mobile Van duty had been to Tikiapara Bazar, Siliguri and found the above noted persons were gathered/ roaming there without wearing mask on their face and without any proper reasons. Two of them namely Uttam Bhadra and Aditya Mahanta were roaming with their vehicle noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
