Jaidul (24 yrs) s/o- Md. Hafijul of Ashrafnagar, Iskan Mandir Road, W/No. 41, PS- Bhaktinagar, Dist- Jalpaiguri, (v) Rajababu Sha (26 yrs) s/o- Ramesh Sha of Bhanga more, PS- Mathabhanga, Dist- Coochbehar, (vi) Santos Das (45 years) s/o- Lt. Jatin Das of Tikiapara, 1 No. Matangini Colony, W/No- 28, PS- Siliguri, Dist- Darjeeling, (vii) Kartik Das (28 yrs) Lt. I, SI Suraj Chhetri of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 30.05.2021 at 12.55 hrs during my R/T mobile van duty, myself along with my accompanied force had been to Court More area under Siliguri PS, found the above noted persons were gathered/ roaming there without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing mask on their face.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no- 486-CS/2021 dated 24.04.2021, memo no- 629-ISS/2M-22/2020 dated 05.05.2021 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
