Sir,

In producing here with the accused person namely-Surji Devi Mondal (50) yrs, W/O-Late Lachhmi Mondal of Santoshi Nagar, Near Rajib Road, ward No-5, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 22 (Twenty Two) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 2200/- (Two thousand Two hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1"

I beg to report that today i.e. On 30-05-21 while performing special raid against illegal alcohol, at 14.45 hrs, I received a source information that one Lady person namely- Surji Devi Mondal (50) yrs, W/O-Late Lachhmi Mondal of Santoshi Nagar, Near Rajib Road, ward No-5, P.S-Siliguri, Dist. Darjeeling, She is selling huge alcohol in the shop of the accd. Person at Burdwan Road, Near Santoshi Nagar More P.S-Siliguri, Dist. Darjeeling. Under Khalpara TOP without any valid license and documents in higher price than the actual value for her illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force and L/C-1216 Puspanjali Yonzon left for at Burdwan Road, Near Santoshi Nagar More, in the shop of accused person, P.S-Siliguri, Dist. Darjeeling to verify the veracity of the information vide Khalpara TOP GDE No -964/21 Dated- 30-05-21. After reaching at Burdwan Road, Near Santoshi Nagar More, Siliguri, Darjeeling at 15.45 hrs and as shown by the source, I found the above noted person are selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept her. On being asked the arrested accused disclosed her identity as mentioned above. During search, I could recover the above noted alcohol kept in the shop of the accd. Person a gunny bag. During interrogation She admitted that She is selling alcohol for her wrongful gain. On demand she failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person are selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 09.05 hrs to 16.05 hrs to 16.45 On 30-05-21.


Under the circumstances one specific case may kindly be started against the arrested accused person namely- Surjidevi Mondal (50) yrs, W/O-Late Lachhmi Mondal of Santoshi Nagar, Near Rajib Road, ward No-5, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation of the case.
