Sir,

In producing herewith one accused person namely Pintu Mondal-23yrs s/o Sri Sushil Mondal of Santoshinagar, Near Ramjanaki Mandir, ward No-V, PS Siliguri Dist Darjeeling along with the following seized articles as per proper seizure list:

1. 25 (Twenty Five) pet bottles of Himalayan Gold 60 up country spirit (each Bottle containing 600ML & in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 2500/- (Two thousand Five hundred only)) which was kept in one gunny bag.

I, SI Srimanta Chatterjee of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodged a written complainant against the above noted person to the effect that on 30.05.21 at 15.50 hrs while performing Spl raid duty (This refers to Khalpara TOP GDE No-964 dated 30.05.21) received an information from Santoshinagar under Siliguri PS that one person has gathered huge quantity of illegal liquor in his house for selling the same in the open market for his wrongful gain. Inform the matter over telephone to you. As per your kind instruction myself along with SI Upendra Nath Roy, ASI Kala Chand Singha, ASI Sanjay Hasda, ASI Aminul Islam and CVF/980 Ranjan Ojha held raid in the house of above noted persons in presence of witnesses and recovered the above noted articles from the possession of above referred person. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in open market for his wrongful gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and level and took signature of the accused person one bottle taken as sample. (The seizure was made in between 17.05 hrs to 17.45hrs) I arrested the accused person u/s 41 Cr.pc. and issued Memo of arrest appraising the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Pintu Mondal-23yrs s/o Sri Sushil Mondal of Santoshinagar, Near Ramjanaki Mandir, ward No-V, PS Siliguri Dist Darjeeling under proper section of law and arrange for investigation..
