In producing herewith five (05) arrested accused persons who disclosed their name & identity as (i) Kiran Sahani (29 yrs) S/O- Kader Sahani of Babupara, opposite Gosala, PS-Siliguri, Dist-Darjeeling, (ii) Kishan Roy (35yrs) S/O- Madan Roy of Lake Town, Nabagram, Ward No-33, PS-NJP, Dist-Jalpaiguri, (iii) Prantosh Mallick (31yrs) S/O- Kishor Kr. Mallick of Ambika Nagar, near Baba Loknath Mandir, PS-NJP, Dist-Jalpaiguri, (iv) Narayan Paul (48yrs) S/O- Lt. Haridas Paul of Ghughumali, near Loknath Mandir, Ward No-36, PS-Bhaktinagar, Dist-Jalpaiguri and (v) Ankit Agarwal (24yrs) S/O- Rajendra Kumar Agarwal of SF Road, near Makhan Bhog, PS-Siliguri, Dist-Darjeeling alongwith their vehicles viz- (i) One green colour Tata Ace bearing Reg No- WB 73C/6260, (ii) one black colour Honda Activa Scooty bearing Reg No- WB 74AN/8020. I SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 31.05.2021 at 11.45 hrs during my R/T Mobile Van duty had been to Mahabirasthan area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
