Today at about 4.55 PM the on duty Medical Officer of the COVID Safe Home, Indoor Stadium, Siliguri has intimated that the UTP Nicolas Tamang S/o Pollat Tamang of Lebung, Lower Bhutia Busty, PS – Sadar, Darjeeling has been untraceable since 12.00 Noon from COVID Safe Home, Indoor Stadium, Siliguri.

In this connection this is also to inform him that One UTP Nicolas Tamang S/o Pollat Tamang of Lebung, Lower Bhutia Busty, PS – Sadar, Darjeeling was received by this Correctional Home on 30/05/2021 evening in connection with Matigara PS Case No. 427/21 DTD. 30/05/2021, G.R. No. 1958/21 u/s 399/402. On admission in this Correctional Home on 30/05/2021 evening the UTP was tested by RAT for COVID-19 from this end and is found COVID – 19 infected.

As per advice of the ACMOH, Siliguri and prevailing COVID – 19 protocol, said COVID – 19 infected UTP Nicolas Tamang was admitted at COVID Safe Home, Indoor Stadium, Siliguri immediately on 30/05/2021 evening.

At about 1.30 PM of today i.e. on 31/05/2021 the on duty warder at the said COVID Safe Home informed over phone that the authority of the COVID Safe Home has intimated that UTP Nicolas Tamang is missing and the matter immediately was communicated to the on duty officer of the Siliguri Police Station over phone. Through searching was conducted by the said COVID Safe Home authority and the on duty warders, but the UTP was not traced out.

He is therefore requested to please do the needful for recapturing of the said UT Prisoner as early as possible by searching the possible hide-outs.
