Order in c/w Covid-19 pandemic as declared by the State Govt. by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons (i) Anukul Barman (20), S/O Dibas Barman of Balason Colony, P.S - Matigara, Dist - Darjeeling, (ii) Jocky Singha (20), S/O Mayal Singha of Bhujipani, P.S - Bagdogra, Dist - Darjeeling, (iii) Sushil Barman (58), S/O Keshob Barman of Khairani Jote, P.S - Bagdogra, Dist - Darjeeling, (iv) Sanjib Dey (22), S/O Sujit Dey of Bidhanpally, P.S - Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation
