Sir,

In producing herewith arrested 01(One) accused person namely; 1) Kartick Sarkar (48) S/O Lt. Kalipada Sarkar of Mulaijote, Natunpara, PO-Gossaipur, PS-Bagdogra, Dist-Darjeeling along with the following article seized under proper seizure list that :

- (a) 71 (Seventy One) strips of Tramadol Hydrochloride, Dicyclomine Hydrochloride & Chlorpheniramine Maleate Capsules each containing 8 (Eight) capsules contained in yellow plastic carry bag and each capsule contain 50 mg Tramadol Hydrochloride, having batch No. SMC-20023 styled as SIMPLEX C +, marked as **Exhibit- "A"**,
- (b) 01 (One) strip of Tramadol Hydrochloride, Dicyclomine Hydrochloride & Chlorpheniramine Maleate Capsules each containing 8 (Eight) capsules, and each capsule contain 50 mg Tramadol Hydrochloride, having batch No. SMC-20023 styled as SIMPLEX C +, marked as **Exhibit- "A 1"**,
(Total Tramadol Hydrochloride weighing 28.8 grams)

I, SI Shishir Saha of Bagdogra P.S. S.P.C do hereby lodge a written complaint against the above mentioned arrested persons to the effect that today on 01.06.2021 at 15.35 hrs. received a source information that one person wearing Grey Coloured T Shirt & Black colored pant with yellow carry bag was going towards Natunpara, Mulaijote with some contraband substances used as drugs. Noted the fact vide GDE No. 41 Dated 01.06.2021. I shared the information with O.C. PS, who directed me to work out the information. Accordingly, I along with ASI Dharendra Nath Mondal, ASI Abu Taleb, Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singh all of Bagdogra PS, SPC left Natunpara, Mulaijote, left PS to work out the information vide GDE No. 42 Dated 01.06.2021 & MCC No. 1532/21 Dated 01.06.2021 at 15.45 hrs. by Govt. vehicle bearing Regd. No. WB 24 K 7669 driven by driver Mukesh Roy taking gala seal, white papers, envelopes, cello tape, etc.

At 16.15 hrs on arrival at Mulaijote, Natunpara near Culvert found one person having same wearing apparel going towards Natunpara. I immediately stopped the vehicle and in no time got down from the vehicle and cordoned him and we disclosed our identity as Police from Bagdogra PS. On interrogation he disclosed his name and address as noted above. On further interrogation what he was carrying inside said plastic carry bag, he disclosed that he was carrying Tramadol tablets to sell to drug addicts in Mulaijote Natunpara. Then, I called two persons namely (i) Shyamai Barman (26) S/O Rubindra Nath Barman and (2) Raja Kumar Jha (25) S/O Satyendra Jha both of Mulaijote, Gosaipur, PS Bagdogra, Dist. Darjeeling and shared the information with them and requested them to be the witness during search and seizure, if any, in writing and both agreed with the proposal.

I then gave them option notice in writing as per provision of the law that whether they wanted to be searched in presence of an Executive Magistrate or Gazetted Officer and they gave in writing that they would prefer to be searched in presence either an Executive Magistrate or Gazetted Officer. Accordingly, I informed the matter to O/C Bagdogra PS and he informed me over mobile phone to send one requisition to Shri Chinmay Mittal, IPS, Assistant Commissioner of Police, Siliguri Police Commissionerate as per his kind order, at 16.55 hrs, I sent a letter through C/410 Mantoah Singh to Shri Chinmay Mittal, IPS, Assistant Commissioner of Police, Siliguri Police Commissionerate, who was deputed as Special Executive Magistrate of SPC, informing him regarding the apprehension of the said accused person possessing suspected to be Psychotropic substance and requested for his presence at Mulaijote, Natunpara near Culvert, under Bagdogra P.S, SPC and to supervise the search and seizure and to perform Magisterial function. Accordingly, at 17.40 hrs Shri Chinmay Mittal, IPS, Assistant Commissioner of Police, Siliguri Police Commissionerate, arrived at the spot to perform magisterial function and he disclosed his name and designation and informed both the witnesses and apprehended accused person that he was present to perform Magisterial function. I offered the independent witnesses and the accused person to search our Police Party as per provisions of law but they did not search the police party. Then after, in presence and under the supervision of Shri Chinmay Mittal, IPS, Assistant Commissioner of Police, Siliguri Police Commissionerate, I searched the apprehended said person and on search of yellow plastic carry bag, recovered above noted seized articles i.e. 72 (Seventy Two) strips of Tramadol Hydrochloride, Dicyclomine Hydrochloride & Chlorpheniramine Maleate Capsules each containing 8 (Eight) capsules, each capsule contain 50 mg Tramadol Hydrochloride, having batch No. SMC-20023 styled as SIMPLEX C +. (Total capsules - 576)

In presence and under the supervision of Shri Chinmay Mittal, IPS, Assistant Commissioner of Police, Siliguri Police Commissionerate and in presence of witnesses and accused person, I randomly took one strip having 8 (Eight) capsules as Sample. I marked remaining 71 strips as Exhibit - "A" and one strip taken as sample as Exhibit - "A-1". I seized under proper seizure by taking the signatures of witnesses and acknowledge by the accused person by putting his signature. The whole process of seizure and label was made in between 18.15 hrs to 19.05 hrs and arrested the above noted accused person U/S 41 CrPC informing the ground of their arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the said accused person namely 1) Kartick Sarkar (48) S/O Lt. Kalipada Sarkar of Mulaijote, Natunpara, PO-Gossaiapur, PS-Bagdogra, Dist-Darjeeling and arrange for its investigation.
