Sir,

In producing herewith two accused persons namely (1) Samir Roy (21 years) S/O Sri Hira Mohan Roy of Dakshin Ektiasal Hut PO Sevoke road PS Bhaktinagar Dist. Jalpaiguri and (2) Umesh Roy (26 years), S/O Sri Karma Roy of Bholanath Para, Near Siliguri Club PS Bhaktinagar Dist Jalpaiguri under custody and the following properties weighing total 24.600 Kgs said to be Ganja under seizure ----

(a) 02 (Two) packets said to be Ganja wrapped with black coloured plastic & brown coloured Cello tap weight 7 (Seven) Kgs 300 Grams & 6 (six) Kgs 300 Grams respectively which was kept in a one Ash coloured luggage hand bag marked as exhibit - "A"  
(b) Net 50 (Fifty) grams of said to be Ganja drew up as sample from each packets of exhibit "A" marked as exhibit "A-1" & "A-2"

(c) 02 (Two) packets said to be Ganja wrapped with black coloured plastic & brown coloured Cello tap weight 6 (six) Kgs, 800 Grams & 4 (Four) Kgs 200 Grams respectively which were kept in a Yellow & red coloured Nylon hand bag marked as exhibit - "B"

(d) Net 50 (Fifty) grams of said to be Ganja drew up as sample from each packets of exhibit "B" marked as exhibit "B-1" & "B-2"

(Seized the above noted articles from the joint possession of accused persons namely Samir Roy and Umesh Roy)

I, S. I. Swapan Ghosh of Ashighar OP P.S. Bhaktinagar SPC, do hereby lodge this complaint to the effect that on 31.05.2021 at 17.45 hrs. received a secret source information that two notorious drug peddlers of Siliguri namely (1) Samir Roy and (2) Umesh Roy are now standing at Baneshwar More, Ashighar with two bags of Ganja in their possession in order for its clandestine disposal at Baneshwar More area and they can be caught red handed, if they are apprehended immediately. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No. 704 dated -31.05.2021 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with ASI Amit Mallick, ASI Krishna Ch Singha, C/1013 Sanjay Singha and CV/909 Nityananda Choudhury all of Ashighar OP left for Baneshwar More, at 17.50 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No. 705 Dated - 31.05.2021. On the way to Baneshwar More, I called two independent witnesses namely [1] Dipankar Saha (31) S/O Shankar Saha of Ghugumali Niranjan Nager PS Bhaktinagar Dist. Jalpaiguri and [2] Sujit Roy (28) S/O Sanjay Roy of Naresht More PO Ghugumali PS Bhaktinagar Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 18.10 hrs. myself along with my accompanying party arrived at Baneshwar More and contacted my source. At 18.20 hrs. a identified by my source myself along with my accompanying party surrounded the above noted accused persons having two hand bags in their possession which they had kept in their middle while standing and waiting for someone. On being asked they disclosed their identify as noted above. On further interrogation they stated that the content inside the hand bags in their possession is Ganja. After disclosing our identity asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and

They agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard. Then at 18.35 hrs. of 31.05.2021 I apprised Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and requested him to remain present at the spot as Gazetted Officer. At 18.55 hrs. Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot. I disclosed the identity of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC to the accused persons as Gazetted Officer. Under supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and the above noted witnesses the aforesaid accused persons and the above noted hand bags were searched keeping strict regard of their decency and recovered Ganja contained inside the four numbers of packets wrapped with black coloured plastic & brown coloured cello tap, which the above noted accused persons were carrying themselves. They further confessed in presence of Gazetted Officer and other witnesses that they procured the Ganja from Assam clandestinely for the purpose of its selling with a view to earn huge money quickly. They further confessed in presence had been dealing in such business for last few years importing it from Assam and selling the same at Ashighar and its adjacent areas. On being asked they failed to produce any documents or license in support of their possession of Ganja. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC I weighed the Ganja with weighing instrument and found that weight of (i) 02 (Two) packets said to be Ganja wrapped with black coloured plastic & brown coloured Cello tap weight 7(Seven)Kgs 300Grams & 6(six) Kgs 300 Grams respectively which was kept in a one Ash coloured luggage hand bag marked as exhibit - "A", Net 50 (Fifty) grams of said to be Ganja drew up as sample from each packets of exhibit "A" marked as exhibit "A-1" & "A-2" and weight of (ii) 02 (Two) packets said to be Ganja wrapped with black coloured plastic & brown coloured Cello tap weight 6(six) Kgs, 800 Grams & 4(Four) Kgs 200 Grams respectively which were kept in a Yellow & red coloured Nylon hand bag marked as exhibit - "B", Net 50 (Fifty) grams of said to be Ganja drew up as sample from each packets of exhibit "B" marked as exhibit "B-1" & "B-2". Then, I packed, labeled and sealed two bags and sample in presence of witnesses, and seized all the above noted recovered articles as Alamats under proper seizure list under the supervision Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 19.25 hrs and 19.55 hrs. Then, I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused persons and witnesses. The copy of seizure list and memo of arrest have been supplied to the above noted accused persons under receipt. Thus, the accused persons violated the terms and conditions of N. D. P. S Act. for possessing Ganja without any legal authority.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Samir Roy (21 years) S/O Sri Hira Mohan Roy of Dakshin Ektiasal Hut PO Sevoke road PS Bhaktinagar Dist. Jalpaiguri and (2) Umesh Roy (26 years), S/O Sri Karma Roy of Bholanath Para, Near Siliguri Club PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
