In producing herewith one Female accused namely Rita Yadav (48) W/O Rampal Yadav of Bhanunagar ,near Shilcon building PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. Seventeen (17 ) Pouch of Officer choice deluxe whisky (each bottle containing 180ML) .
2. Nine (09) pouch of Mc Dowell's no1 (each bottle containing 180 ML) .
3. Seven (07 ) Bottles of Tuborg premium beer (each bottle containing 650 ML) .
4. Five (05 ) Bottles of Himalayan gold 60up country sprit (each bottle containing 600 ML) .
5. Eighteen (18 ) Bottles of Himalayan gold 60up country sprit (each bottle containing 300 ML) .
6. Seven (07 ) Bottles of Black label strong premium beer (each bottle containing 650ML) .
7. Seven (07 ) Bottles of Tuborg premium beer (each bottle containing 650 ML) .
8. Twenty five(25 ) Bottles of Kingfisher strong premium beer (each bottle containing 650 ML) .
9. One (01 ) Bottles of McDowell,s no1 whisky (each bottle containing 375 ML) .

I, LSI Niden Sherpa of Bhaktinagar PS,SPC lodged a written complainant against the above noted female accused to the effect that today i.e. on 02.06.2021 hrs at 08.25 hrs received a source information that at the house of Rita Yadav (48) W/O Rampal Yadav of Bhanunagar ,near Shilcon building PS- Bhaktinagar Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Bhaktinagar PS GDE no-66 dated 02.06.21. I informed to I/C Bhaktinagar PS about the information . As per his kind instruction I along with, ASI Biswajit Saha,CVF/619 Dharmendra Roy, CVF/935 Biplab Roy as proceed to at Bhanunagar ,near Shilcon building ,PS-Bhaktinagar,Jalpaiguri to work out the information. At 08.55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Rita Yadav (48) W/O Rampal Yadav of Bhanunagar ,near Shilcon building PS- Bhaktinagar Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted female accused person namely Rita Yadav (48) W/O Rampal Yadav of Bhanunagar ,near Shilcon building PS- Bhaktinagar Dist- Jalpaiguri . On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. In presence of witnesses namely 1) Malin Ch Roy S/O Monoranjan Roy of Dakshin palash ,Natun Bazar PS-Pradhanagar Dist-Darjeeling. I seized the above noted articles from the possession of above noted female accused after preparing proper seizure list and took signature of the accused and witnesses. The seizure was made between 09.15 hrs to 09.45 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the female accused namely Rita Yadav (48) W/O Rampal Yadav of Bhanunagar ,near Shilcon building PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
