Sir,

I, ASI Ratan Pradhan of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint and producing one accused person namely Puspa Thapa (40), W/O- Rajesh Thapa of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling along with i) 08 (Eight) bottles of Emboss Fine Whisky containing 750 ml each, ii) 16 (Sixteen) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, iii) 14 (Forteen) bottles of Black Label Strong premium Beer containing 650 ml each, iv) 08 (Eight) bottles of Tuborg premium Beer containing 650 ml each, which has been seized under proper seizure list, to the effect that on 01.06.2021 at 14.20 hrs I received secret source information that one lady namely Puspa Thapa is selling illegal liquors at Milan more area. Accordingly informed the matter to the I/C Pradhan nagar P.S., SPC and as per his kind direction myself along with ASI Debasish Das, ASI Ashit Singha, LC/1263 Sujata Thapa, LC/036 Shefali Barman, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, all of Pradhan nagar P.S. left for Milanmore to verify the veracity of the source information vide Pradhan nagar P.S. GDE. No. 41, Dated- 01.06.2021 at 14.25 hrs. On reaching at the spot at 14.40 hrs and after being confirmed by the source and we cordoned the area and search has been conducted inside her stall and recovered i) 08 (Eight) bottles of Emboss Fine Whisky containing 750 ml each, ii) 16 (Sixteen) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, iii) 14 (Forteen) bottles of Black Label Strong premium Beer containing 650 ml each, iv) 08 (Eight) bottles of Tuborg premium Beer containing 650 ml each. On asking the said Puspa Thapa failed to produce any documents in respect of said recovered liquors.. It is a violation under Bengal Excise Act. I accordingly seized the said liquors under proper seizure List duly signed by her and the witnesses. This seizure was made in between 15.20 hrs to 16.05 hrs. I arrested the accused person namely Puspa Thapa (40), W/O- Rajesh Thapa of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling, U/S-41 Cr.PC after maintaining decency and preparing memo of arrest and intimating the ground of arrest. At 17.05 hrs the arrested accused person along with seized articles has taken to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested lady accused person namely Puspa Thapa (40), W/O- Rajesh Thapa of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling and arrange for its investigation.
