Sir,

I, ASI Debasish Das of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint and producing one accused person namely Gopal Biswakarma (56), S/O- Dal Bahadur Biswakarma of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling along with i) 48 (Fourty eight) bottles of Emboss Fine Whisky containing 750 ml each, ii) 20 (Twenty) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, iii) 48 (Fourty eight) bottles of Black Label Strong premium Beer containing 650 ml each, iv) 24 (Twenty four) bottles of Officer's Choice Delux Whisky containing 180 ml each, which have been seized under proper seizure list to the effect that on 01.06.2021 at 14.15 hrs received secret source information that one Gopal Biswakarma is selling illegal liquors from his house-cum-shop at Milan more. Accordingly informed the matter to the I/C Pradhan nagar P.S., SPC and as per his kind direction myself along with ASI Ashit Singha, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, all of Pradhan nagar P.S. left for Milan more vide Pradhan nagar P.S. GDE. No. 41, Dated- 01.06.2021 at 14.25 hrs to verify the veracity of the source information. On reaching at the spot at 14.45 hrs and after being confirmed by the source cordoned the area and conducted search and recovered i) 48 (Fourty eight) bottles of Emboss Fine Whisky containing 750 ml each, ii) 20 (Twenty) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, iii) 48 (Fourty eight) bottles of Black Label Strong premium Beer containing 650 ml each, iv) 24 (Twenty four) bottles of Officer's Choice Delux Whisky containing 180 ml each. On demand said Gopal Biswakarma failed to produce any document in respect of recovered liquors. Thus, it is a violation of Bengal Excise Act. Accordingly, I seized the said liquors under proper seizure List duly signed by him and the witnesses. The seizure was made in between 15.20 to 16.35 hrs. I arrested the accused person namely Gopal Biswakarma (56), S/O- Dal Bahadur Biswakarma of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling U/S-41 Cr. PC after preparing memo of arrest and intimating the ground of arrest. At 17.15 hrs the arrested accused person along with seized articles has been brought to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested accused person namely Gopal Biswakarma (56), S/O- Dal Bahadur Biswakarma of Milanmore, Karaibari, P.S. Pradhan nagar, Dist- Darjeeling and arrange for it's investigation.
