With due respect, I am producing herewith the arrested accused person namely Kamal Chhetri (48 yrs) S/O late Sher Bahadur Chhetri of Vill- Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 66 (Sixty six) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 15 (fifteen) bottles of Old Monk XXX Premium RUM containing 180 ML in each bottle of Rs 153/- of each bottle.
3. 09 (Nine) bottles of Imperial Blue Classic Grain Whisky containing 180 ml in each bottle of Rs 174/- each bottle.
4. 12 (Twelve) bottles of Sterling Reserve Whisky containing 180 ML in each bottle of Rs 204/- of each bottle.
5. 25 (Twenty five) numbers of paper made pouch of Officer Choice Deluxe Whisky containing 180 ml in each pouch of MRP Rs 140/- in each pouch.
6. 05 (five) bottles of HAYWARDS 5000 Super Strong Beer containing 650 ML in each bottle of Rs 130/- of each bottle.

I beg to state that today i.e. on 01.06.21 at 20.45 hrs I received a secret source information that one person named Kamal Chhetri of Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri is selling ID liquor at his residence at Ram Nagar Colony for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 40 dated 01.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Pares Rava, VP/13 Jamirul Islam and CV/306 Biswajit Roy left for Ram Nagar Colony to work out the information in hand. At about 21.25 hrs we arrived at the house of accused Kamal Chhetri of Vill- Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri and being shown and identified by the source we managed to intercepted one person who disclosed his name and identity as Kamal Chhetri (48 yrs) S/O late Sher Bahadur Chhetri of Vill- Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accd Kamal Chhetri (48 yrs) S/O late Sher Bahadur Chhetri of Vill- Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The total value of seized articles is Rs 17059/-. The whole process of search seizure & arrest was made in between 21.45 hrs and 22.25 hrs.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kamal Chhetri (48 yrs) S/O late Sher Bahadur Chhetri of Vill- Ram Nagar Colony, PO- Sahudangi Hat, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
