With due respect, I am producing herewith the arrested accused persons namely (i) Sourav Biswas @ Puchka (21 yrs) S/O Ram Prashad Biswas of Bhola More, PS- NJP, Dist.- Jalpaiguri (ii) Subham Dutta @ Pappu (21 yrs) S/O Raju Dutta of Mamata Para, PS- NJP, Dist.- Jalpaiguri and (iii) Gopal Mahanta @ Abinash (21 yrs) S/O Ranjan Mahanta of Mamata Para, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made hasua and one sharp cutting knife from the possession of accused Sourav Biswas @ Puchka (21 yrs) S/O Ram Prashad Biswas of Bhola More, PS- NJP, Dist.- Jalpaiguri.
2. One Sabol measuring approx 30 inches in length from the possession of accused Subham Dutta @ Pappu (21 yrs) S/O Raju Dutta of Mamata Para, PS- NJP, Dist.- Jalpaiguri.
3. One plastic made charger torch light and one bamboo made lathi from the possession of accused Gopal Mahanta @ Abinash (21 yrs) S/O Ranjan Mahanta of Mamata Para, PS- NJP, Dist.- Jalpaiguri.

I, SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate beg to state that on 02.06.21 at 00.35 hrs I received a secret source information that a gang of miscreants come to Ambika Nagar More with deadly weapons and assembled there and making preparation for committing dacoity at Ambika Nagar area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 51 dated 02.06.21. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, C/1053 Paresh Rava, VP/13 Jamirul Islam and CV/306 Biswajit Roy left for Ambika Nagar More to work out the information in hand. I also informed the fact to night RT Van officer SI Kamallesh Joarder and directed him to come to Ambika Nagar More to accompany with us. At about 01.05 hrs on 02.06.21 we arrived at Ambika Nagar More. After a few time SI Kamallesh Joarder along with force came to Ambika Nagar More and accompany with us. At about 01.45 hrs we found that 10/12 persons assembled in a dark place at Ambika Nagar More and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended the 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and they also admitted that they had assembled there to commit dacoity in that area.
