In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Satyajit Das (30yrs) S/O- Lt. Manik Das of Shaktigarh, Ward No-31, Pragatipara, PS-NJP, Dist-Jalpaiguri, (ii) Ranjit Roy (35yrs) S/O- Nakul Roy of Shantipara, PS-Bhaktinagar, Dist-Jalpaiguri, (iii) Rabi Das (38yrs) S/O- Lt. Vola Das of Surya Sen Colony, PS-NJP, Dist-Jalpaiguri, (iv) Tinku Mandal (42yrs) S/O- Lt. Akhil Mandal of Kolahati, Khalpara, Ward No-8, PS-Siliguri, Dist-Darjeeling, (v) Surya Sen Barua (50yrs) S/O- Jatin Barua of Ambika Nagar, near Chat Pukur, PS-NJP, Dist-Jalpaiguri, (vi) Bishnu Das (45yrs) S/O- Sudhir Das of Tikiapara, Majdur Colony, Ward No-28, PS-Siliguri, Dist-Darjeeling alongwith their vehicles viz. (i) Toto without number (ii) Toto maroon colour without number. ISI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on \$1.06.2021 at 10.35 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Two of theme namely Surya Sen Barua & Bishnu Das were roaming with theirvehicle noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. Of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act. 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
