Sir,

With due respect, I Sri Mithilesh Singh, S/o Sri Muneswar Singh, resident of Santoshi Nagar, S.M.C. Ward No.-5, P.O.-Siliguri Bazar, P.S.-Siliguri, Dist-Darjeeling, would like to inform you that on 22-5-2021 at about 2 pm, my daughter namely Bindushi Kumari Singh, aged about 18 years who is reading in Class XI had been to tuition teacher name K Guddu Soenkar, S/o Umesh Soenkar, resident of Khalaibaktari, Matigara, P.O. & P.S.-Matigara, Dist-Darjeeling for tuition purpose at his rented house at Santoshi Nagar. When my said daughter did not returned to my house, I alongwith my well wishers tried our level best to trace out my said daughter but all efforts were became vain. Finding no other alternative, on the same day i.e. 22-5-2021, I have lodged a missing dairy before you in that regard, having GDF No.-737 dated 22-5-2021.

Till now my said daughter is yet to be recovered and from the whisperings in the locality, I came to know that some miscreants have kidnapped my said daughter and in the said incident of kidnapping I reasonably believe and suspect that the said Guddu Soenkar and one Suraj Parihar having Ph No - 8964823863 and some friends of my daughter are directly involved in the said incident of kidnapping of my daughter.

I do reasonable belief that they above named persons and their associates may involve my daughter in flash trade or they will sale out my daughter if my daughter be not recovered immediately.

So requesting you to investigate the matter and recover my daughter and take necessary legal action against the offender for the interest of justice.
