On reaching there at about 19.25 hrs I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the house while during cordoning of the house some customers having liquor on the house and fied away. Subsequently the above noted articles were found in the house of said Ajay Ghosh who, being asked failed to produce any valid documents/papers in support of possessing and selling of the liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his shop under proper seizure list and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 19.35 hrs to 20.50 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Ajay Ghosh (40), S/O Nemai Ghosh of Mulaijote Gosainpur PS- Bagdogra, Dist- Darjeeling and amange for its investigation.
