Sir,

In producing herewith one person namely Ajay Ghosh (40), S/O Nemai Ghosh of Mulaijote Gosainpur PS- Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure,

1. 08 (eight) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1".
2. 03 (three) bottles of Imperial Blue Classic Grain Whisky (each bottle containing 375 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".
3. 03 (three) bottles of Mc Dowell's No-1 Luxury Premium Whisky (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1".
4. 08 (Eight) bottles of Mc Dowell's No Celebration Matured XXX Rum (each bottle containing 180 ml.) marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1".
5. 10 (Ten) Pouch of Officer's Choice Deluxe Whisky (each bottle containing 180 ml.) marked as Exhibit "E" from which 01 bottle randomly taken out as sample and marked as Exhibit "E-1".

I, ASI Dharendra Nath Mandal of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Ajay Ghosh to the effect that today i.e., on 03.06.21 at about 19.10 hrs received source information that one person is selling illicit liquor at Mulaijote Gosainpur area from the house accused Ajay Ghosh and huge quantity of illicit liquor is stored in his house. Accordingly I shared the informed with you and as instructed had been to Mulaijote Gosainpur to work out the information. On reaching there at about 19.25 hrs I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the house while during cordoning of the house some customers having liquor on the house and fled away. Subsequently the above noted articles were found in the house of said Ajay Ghosh who, being asked failed to produce any valid documents/papers in support of possessing and selling of the liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his shop under proper seizure list and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 19.35 hrs to 20.50 hrs.


