In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Arjun Poddar (63yrs) S/O- Lt. Sitaram Poddar of Coolipara Rajendra Nagar, Ward No-01, near Kiran Chandra Burning Ghat, PS-Pradhan Nagar, Dist-Darjeeling, (ii) Suranjan Das (48yrs) S/O- Lt. Nitya Gopal Das of Deshbandhupara, near Srinivas Sewa Sadan, Ward No-30, PS-Siliguri, Dist-Darjeeling, (iii) Md. Hasibul (26yrs) S/O- Md. Basiruddin of Jubivita Mahananda Bridge, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Nirmal Dutta (51yrs) S/O- Lt. Ram Kanai Dutta of Deshbandhupara, near Terai School, PS-Siliguri, Dist-Darjeeling, (v) Smt. Binta Tamang (25yrs) W/O- Atul Tamang of Salbari Pathar ghata, Monokamakha Residency, PS-Sukna, Dist-Darjeeling and (vi) Atul Tamang (26yrs) S/O- Arun Tamang of Salbari Pathar ghata, Monokamakha Residency, PS-Sukna, Dist-Darjeeling alongwith their vehicles viz- (i) Toto green colour bearing No- SMC-O-2285, (ii) Toto light green colour bearing Reg No- WB 73F/3945, (iii) Toto red colour without number, (iv) Toto deep blue colour bearing No- WB 73C/3221 & (v) One Innova Car white colour bearing No- WB 78/3153. I SI Malay Kumar Roy of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 02.06.2021 at 11.35 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.


Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
