In producing herewith ten (10) arrested accused persons who disclosed their name & identity as (i) Hasibul Rahaman (35yrs) S/o- Md. Rajjak of Mastam Chowk, Thakurganj, PS-Thakurganj, Dist-Kishanganj, Bihar, (ii) Jamal Anwar (32yrs) S/O- Lt. Md. Basir of Baghmara, PS-Thakurganj, Dist-Kishanganj, Bihar, (iii) Ganesh Banik (26yrs) S/O- Lt. Sanjit Banik of Uttar Shantinagar, PS-Bhaktiagar, Dist-Jalpaiguri, (iv) Arjun Roy (27yrs) S/O- Lt. Disa Roy fo Debasish Colony, Dakshin Bharatnagar, PS-Siliguri, Dist-Darjeeling, (v) Abishek Roy (18yrs) S/O- Santosh Roy of Medical Kawakhali, near CRPF Camp, Kawakhali, PS-Matigara, Dist-Darjeeling, (vi) Saikat Dey (20yrs) S/O- Lt. Parimal Dey of Mahanandapara, Ward No-4, PS-Siliguri, Dist-Darjeeling, (vii) Monoj Thakur (32yrs) S/O- Jamdar Thakur of Bagrakote Local Busstand, Ward No-18, PS-Siliguri, Dist-Darjeeling, (viii) Md. Ali (50yrs) S/O- Lt. Saidul Islam of Tinbatti Kasmir Colony, PS-NJP, Dist-Jalpaiguri, (ix) Binod Kamti (42yrs) S/O- Bahuli Kamti of Ramnagar, Majdoor busty, PS-NJP, Dist-Jalpaiguri and (x) Ratan Sarkar (32yrs) S/o- Lt. Swapan Sarkar of Uttar Bharat Nagar, Ward No-24, PS-Siliguri, Dist-Darjeeling alongwith three vehicles viz- (i) Toto blue colour without number & (ii) Toto red colour bearing No WB 73F/3582 & (iii) Toto blue colour without number. I SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 02.06.2021 at 21.05 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Three of them namely Ratan Sarkar, Binod Kamti and Md. Ali were roaming with their respective vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
