Kalipada Dutta of Morebazar, Near NJP Police Station, PS-NJP, Dist- Jalpaiguri, (iv) Sujit Saha (32yrs) S/O- Ranjit Saha of Janatanagar, Ward No-44, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Bachan Mahato (31yrs) S/O- Janardhan Mahato of NJP, Bhaktinagar, near Bibadi Sangha Club, PS-NJP, Dist-Jalpaiguri, (vi) Om Prakash Poddar (37yrs) S/O- Bholanath Poddar of South Colony Jabravita, Fulbari near Reliance Tower, PS-NJP, Dist-Jalpaiguri, (vii) Ashim Mandal (47yrs) S/O- Ramananda Mandal of Ashighar Colony, Naresh More, PS-Bhaktinagar, Dist-Jalpaiguri, (viii) Animesh Mandal (56yrs) S/O- Lt. Ranjit Das of Uttar Shantinagar, Pangani Para, PS-Bhaktinagar, Dist-Jalpaiguri and (x) Rajesh Das (24yrs) S/O- Mahadev Das of Madhya Shantinagar near Loknath Mandir, Ward No- 36, PS- Bhaktinagar, Dist- Jalpaiguri alongwith their six TOTO viz- (i) Toto blue colour without number, (ii) Toto blue colour without number, (iii) Toto royel blue colour without number, (iv) Toto red colour bearing Reg No. WB 71/0663, (v) Toto green colour without number & (vi) Toto yellow & green colour being Reg No- WB 71B/6101. I SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 02.06.2021 at 20.45 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Six of them were roaming with their respective TOTOs noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
