In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Ajay Sha (33yrs) S/O- Lt. Kapil Sha of Prakash Nagar, near Checkpost, PS-Bhaktinagar, Dist-Jalpaiguri, (ii) Rambalak Paswan (40yrs) S/O- Lt. Ramprakash Paswan of Pradhannagar, Rambhajan Colony, Ward No-3, PS-Pradhan Nagar, Dist-Darjeeling, (iii) Gopal Das (42yrs) S/O- Madhu Das of Ambikanagar, near School Math, PS-NJP, Dist-Jalpaiguri, (iv) Sumit Kumar Jha (36yrs) S/O- Lt. Amar Kanta Jha of Bharatnagar, Ward No-24, near Tarun Tirtha Club, PS-Siliguri, Dist-Darjeeling, (v) Tapash Roy (28yrs) S/O- Nidam Roy of Barivasha, near Green Land school, PS-NJP, Dist-Jalpaiguri, (vi) Uttam Kumar Dey (53yrs) S/O- Lt. Gouranga Ch. Dey of Milanpally, near Ramthakur Mandir, Ward No-25, PS-Siliguri, Dist- Darjeeling and (vii) Bipul Das (44yrs) S/O- Provat Das of Milanpally, Ward No-25, near Ram Thakur Mandir, PS-Siliguri, Dist-Darjeeling alongwith their vehicles viz- (i) Toto red colour without number, (ii) Toto bearing Reg No- WB 73TC/0583, (iii) Toto light blue colour without number, (iv) Toto red colour bearing No. WB 71/0976 & (v) Toto blue colour bearing No- WB 73F/2743. I SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 03.06.2021 at 11.25 hrs during my R/T Mobile Van duty had been to Hospital More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face, without any proper reasons and along with their respective vehicles.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
