In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Sankar Singh (31yrs) S/O- Suran Singha of Sitalapara, PS-NJP, Dist-Jalpaiguri, (ii) Sanjoy Mandal (32yrs) S/O- Lt. Umesh Mandal of Deshbandhupara near Srinivas Seba Sadan, Ward No- 30, PS-Siliguri, Dist-Darjeeling, (iii) Md. Ibrahim (33yrs) S/O- Md. Ismail of Tikiapara, Matangini Colony, Ward No-28, PS-Siliguri, Dist-Darjeeling, (iv) Prafulla Roy (37yrs) S/O- Jyotish Roy of Jamrivita, Bholamore, PS-NJP, Dist-Jalpaiguri, (v) Nirmal Dey (48yrs) S/O- Lt. Nripen Dey of South Colony, Pachkelguri, Bhalobasa More, PS-NJP, Dist-Jalpaiguri, (vi) Partha Pratim Roy (19yrs) S/O- Prafulla Roy of C/O- Abala Roy, Saktigarh, Road No-2, PS-NJP, Dist-Jalpaiguri, (vii) Sk. Sahabuddin (34yrs) S/O- Sk. Suddu of Adarsha Nagar Colony near Madrasa, Ward No-4, PS-Siliguri, Dist-Darjeeling alongwith their vehicles viz- (i) Toto red colour bearing No. WB 73F/8112, (ii) Toto red colour without number, (iii) Toto red colour without number, (iv) Toto white colour without number, (v) Toto green colour without number, (vi) Toto black colour without number and (vii) Toto red colour bearing No- WB 73F/6356. I SI Swapan Basu Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 03.06.2021 at 16.25 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming along with their respective vehicles without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
