Bagdogra, Dist-Darjeeling, (2) Md. Ajmer Ansari (33 Years) S/O Md. Islam Ansari of Panchkalguri, Nemai, PS. Nemai, Dist-Darjeeling (3) Samiran Paul (25 years) S/O Ramani Paul of Pal Para, P.S.Matigara, Dist-Darjeeling, (4) Bijay Das (23 Years) S/O Laxman Das, of Narayan Pally, Shivmandir, PS. Matigara, Darjeeling, (5) Prabir Mukherjee (49 Years), S/O Late Bhabotosh Mukherjee of Sree Colony, P.S. Bagdogra, Dist-Darjeeling, (6) Manoj Roy (42years) S/O Biren Roy of Maszid Para, P.S Bagdogra, Dist-Darjeeling disobeying order of Lock down and social distance.
