Sir,

In producing herewith one person namely Dilip Pradhan 42yrs s/o Late Shyam Bahadur Pradhan of Lalit Nagar Bagdogra PS- Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure.

1. 16 (sixteen) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1".
2. 08 (eight) bottles of Mc Dowell's No Celebration Matured XXX Rum (each bottle containing 180 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".
3. 10 (ten) Pouch of Officer's Choice Deluxe Whisky (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1".
4. 04 (four) bottles Black Cat Special Rum (each bottle containing 180 ml.) marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1".

I, ASI Dharendra Nath Mandal of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Dilip Pradhan to the effect that today i.e., on 05.06.21 at about - 21.05 hrs received source information that one person is selling illicit liquor at Lalit Nagar from one shop styled as "Suraj Resturant" accused Dilip Pradhan and huge quantity of illicit liquor is stored in his shop. Accordingly I shared the information with you diarized the fact vide GDE no 252 and as instructed had been to Lalit Nagar shop styled as "Suraj Resturant" to work out the information. On reaching there at about 21.15 hrs, I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the shop while during cordoning of the shop some customers having liquor on the said shop and fled away. Subsequently the above noted articles were found in the house of said Dilip Pradhan who, being asked failed to produce any valid documents/papers in support of possessing and selling of the liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his shop under proper seizure list and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 21.25 hrs to 22.15 hrs.




