In producing herewith one accused person namely Dilip Roy(46)S/O- Anil Roy Shanti Colony ,PS- Bhaktinagar, Dist.- Jalpaiguri along with following seized articles

1. 08(Eight) bottles of Kingfisher Strong premium beer each bottle containing 650ML manufactured by United Breweries LTD. ,Vittal Mallya Road ,Kalyani, West Bengal .
2. 06(Six) bottles of Black label strong premium beer each bottle containing 650 ml. manufactured by United Breweries LTD. ,Vittal Mallya Road ,Kalyani, West Bengal.
3. 34(thirty four) bottles of Himalayan Gold Country Spirit each bottle containing 600ML manufactured Himalayan Endeavors Pvt. LTD. Siliguri.
4. 09(nine) bottles of Himalayan Gold Country Spirit each bottle containing 300ML manufactured Himalayan Endeavors Pvt. LTD. Siliguri.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Dilip Roy(46)S/O- Anil Roy Shanti Colony ,PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 05.06.2021 at 18:35 hrs while myself along with force were performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO-301 date 05.06.2021, received a specific input from the source that the above noted person was selling illicit liquor in his Hotel cum residence at Shantinagar Colony , under Bhaktinagar P.S to local people . Accordingly the fact is informed to I/C Bhaktinagar PS and as per his direction I along with ASI Biplab Kumar Roy ,CV. 614 Sumit Roy ,CV-619 Dharmendra Roy and CV 14 Labanyamoy Barman left for Shanti Colony under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned his hotel cum residence where he kept illegal alcohol to sale his design customers . On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his Hotel in conceal position. On searching found huge numbers of above noted illegal liquor . On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 04 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19.35 hrs to 19.55 hrs. On being asked he stated that he kept the same with a view to sale and supply at Shanti Colony area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Dilip Roy(46)S/O- Anil Roy Shanti Colony ,PS- Bhaktinagar, Dist.- Jalpaiguri as per proper section of law.
