



In this regard I beg to complain that on 05.06.2021 while performing K-31-II van duty vide GDE No.238 Dated 05.06.2021 at around 17:55 hrs I found that the above noted persons had come out of their house without any specific purpose and moving freely on the Champasari area. I shared the information with you and as per your direction, I along with force brought the persons under arrest as they violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 - 01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. On interrogation, they all disclosed their names and address as noted above. On further grilling, all of them admitted that they all were aware of the Lockdown Order and restrictions imposed upon the movement of human being and they had been moving without any specific reason. As they had violated the order of lockdown promulgated by the appropriate authority and also the provisions of Disaster Management Act, 2005, I with the help of force arrested them U/S 41 Cr.PC preparing proper memo of arrest.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
