

Sir,

In producing herewith one arrested person namely Sangay Tamang (22), s/o Kamal Kumar Tamang of Thorbu T.E Ward No.9 PS- Mirik, Dist. Darjeeling A/P Siliguri Junction PS-Pradhannagar Dist-Darjeeling along with following articles under proper seizure list:- **i)** Tuborg strong premium Beer 15 bottles each bottle containing 650 ml. **ii)** Kingfisher Beer 14 bottles each bottle containing 650 ml **iii)** MC Dowells no.1 Celebration RUM 4 bottles each bottle containing 375ml. **iv)** Himalayan 60UP 39 bottles each bottle containing 300 ml **v)** Royal Choice Country Spirit 12 bottles each bottle containing 600ml **vi)** Officers choice 7 bottles each bottle containing 750 ml. **vii)** officer's choice pouch 12 pieces each containing 180 ml.(approx. total- 47 ltrs)


I, ASI Ratan Pradhan of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 05.06.2021 16:45 at hrs, I received a source information that one person namely Sangay Tamang has stored huge quantity of illicit liquor in his hotel styled as "Durga Hotel" and selling the same illegally. Accordingly, I share the information with you and as per your kind instruction diarized mater vide Pradhannagar PS GDE No.248 Dated-05.06.2021 and myself along with ASI Debashish Das ,CV/646 Baban Das & CV/645 Pankaj Gupta and all of Pradhannagar PS,SPC left PS for junction area to verify the veracity of the information. After reaching at Siliguri Junction the source identified the hotel and person. I tried to collect local witnesses for search and seizure, but due to lockdown nobody was present there. Accordingly, I apprehended the above noted person and conducted raid and recovered above noted articles from inside his Hotel-cum-shop. On demand he failed to produce any valid document in favor of recovered articles. On interrogation he admitted that he had been selling the same illegally since long for his illegal gain. Accordingly I seized the above noted articles under proper seizure list. The seizure has made between 17.15 hrs to 18.20 hrs & labeled the same and arrested him and issued memo of arrest at 18.25 hrs. Accordingly myself along with force, arrested accused and seized articles returned at P.S. at 19.05 hrs.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sangay Tamang (22) s/o Kamal Kumar Tamang of Thorbu T.E Ward No.9 PS- Mirik , Dist. Darjeeling A/P Siliguri Junction PS-Pradhannagar Dist-Darjeeling and arrange for its investigation.
