In producing herewith one arrested person namely Lal Babu Rai (59), S/O-Lt. Chulai Rai of Debidanga Bazar, Champasari P.S- Pradhan Nagar, Dist. 1, ASI Asit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 05.06.2021 16:15 at hrs, I received a source information that one person namely Lal Babu Rai (67), S/O-Lt. Chulai Rai of Debidanga Bazar, Champasari under PDN PS stored huge quantity of illicit liquor in his hotel-cum shop styled as "Jay Guru Hotel" and selling the same locally. Accordingly, I share the information with you and as per your kind instruction diarized mater vide Pradhannagar PS GDE No.248 Dated-05.06,2021 and myself along with ASI Ratan Pradhan, CV/131Ranjan Sharma & CV/645 Pankaj Gupta & CV- 128 Ajay Sahani all of Pradhannagar PS,SPC left PS for Debidanga to verify the veracity of information. After reaching at Debidanga bazar the source identified the hoteicum-shop and person. I tried to collect local witnesses for search and seizure, but due to lockdown nobody was present there. Accordingly, I apprehended the above noted person and conducted raid and recovered above noted articles from inside his Hotel-cum-shop styled as "Jay Guru Hotel". On demand he failed to produce any valid document in favor of recovered articles. On interrogation he admitted that he had been selling the same illegally since long for his illegal gain. Accordingly I seized the above noted articles under proper seizure list. The seizure was made between 17.05 hrs to 18.30 hrs & labeled the same and at 18.45 hrs arrested him and issued memo of arrest. Accordingly myself along with force, arrested accused person and seized articles returned at P.S. at 19.25 hrs and informed to you as well.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Lal Babu Rai (59) S/O- Lt. Chulai Rai of Debidanga Bazar Champasari P.S- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
