In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Saifish Kr. Mandal (22yrs) S/O- Mataru Mandal of Matigara, Tumbajore gram Panchaye-2, PS-Matigara, Dist-Darjeeling, (ii) Abhijit Sarkar (30yrs) S/O- Sankar Sarkar of 2 No Jyotinagar Colony, Ward No-4, PS-Siliguri, Dist-Darjeeling, (iii) Biju Ghosh (28yrs) S/O- Gopal Ghosh of Jhankar More, Gowala Patty, Ward No-4, near Matri Sangha Club, PS-Siliguri, Dist-Darjeeling, (iv) Bappa Das (31yrs) S/O- Hiren Das of Dakhin Santinagar, 2 No Dabgram, PS-NJP, Dist-Jalpaiguri, (v) Ranjit Sutradhar (45yrs) S/O- Moni Sutradhar of Eastern by Pass, Debinagar, Ward No-40, PS-Bhaktinagar, Dist-Jalpaiguri, (vi) Jiban Barman (20yrs) S/O- Mantu Barman of Sevoke road, Dasarathpally, Ward No-44, PS-Bhaktinagar, Dist-Jalpaiguri, (vii) Sujit Banik (34yrs) S/O- Subash Banik of Sipaipara, Fulbari, near Chotobhai Spring Club, PS-NJP, Dist-Jalpaiguri, (viii) Joydeb Ghosh (32yrs) S/O- Jayanta Ghosh of Junction Siliguri, near Hindi Bharati High School, Ward No-47, PS-Pradhan Nagar, Dist-Darjeeling alongwith their five TOTOs viz- (i) Toto yellow colour bearing No. SMC-2248, (ii) Toto red colour without number, (iii) Toto red colour bearing No- WB 73F/6542, (iv) Toto green colour bearing No- WB 73F/1521 & (v) Toto blue colour without number. I SI Malay Kumar Roy of Siliguri PS/ SPC do hereby lodge this complaint against the above noted arrested persons to the effect that, on 04.06.2021 at 12.10 hrs during my R/T Mobile Van duty had been to Court More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Five of them were roaming with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
