In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Dhananjay Shil (35yrs) S/O- Lt. Surendra Nath Shil of South Colony, Pachkalguri, near Bhalobasa More, PS-NJP, Dist-Jalpaiguri, (ii) Sabiqul Mia (36yrs) S/O- Md. Nijamuddin Mia of Milanpally, near Kali Mandir, Ward No-25, PS-Siliguri, Dist-Darjeeling, (iii) Nur Alam (25yrs) S/O- Md. Jakir Hussain of Dasarath Pally Bazar, Ward No-44, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Chittaranjan Roy (51yrs) S/O-Lt. Haridas Roy of Surja Sen Colony, Block-C, near Radha Gobinda Mandir, PO- Siliguti Town, PS-NJP, Dist-Jalpaiguri, (v) Ratan Saha (38yrs) S/O- Dhiren Shaa of Madhya Santinagar, 2 No Dabgram, PS-Bhaktinagar, Dist-Jalpaiguri, (vi) Subash Sahani (44yrs) S/O- Baleswar Sahani of Sahid Colony, Ward No-35, near IOC gate, PS-NJP, Dist-Jalpaiguri, (vii) Deepak Dey (41yrs) S/O- Subash Dey of Junction Siliguri, Ward No-47, PS-Pradhannagar, Dist-Darjeeling, (viii) Mohammad Gulab (30yrs) S/O- Lt. Ishak of Darbhangatola, Ward No-6, PS-Siliguri, Dist-Darjeeling alongwith their vehicles viz- (i) Toto yellow colour without number, (ii) Toto red colour without number, (iii) Toto red colour without number & (iv) Toto white & blue colour bearing No- WB 73F/1913. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge this complaint against the above noted arrested persons to the effect that, on 04.06.2021 at 12.10 hrs during my R/T Mobile Van duty had been to Court More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Four of them were roaming with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
