In producing herewith 07 (seven) arrested persons namely (i) Abhijit Sarkar-20yrs s/o Bapi Sarkar of Gawalapatty, Ward No-IV, PS Siliguri Dist Darjeeling (ii) Subrata Mallick-42yrs s/o Pratul Chandra Mallick of Jyotinagar, Near Charakmath Ward No-IV PS Siliguri Dist Darjeeling (iii) Gouranga Das-28yrs s/o Gobinda Das of Jyotinagar Near Shiv Mandir ward no-IV, PS Siliguri Dist Darjeeling (iv) Manoj Mandal-38yrs s/o Lt Jogendar Mandal of Shibaji road, Khalpara ward No-VIII, PS Siliguri Dist Darjeeling (v) Manoj Agarwal-40yrs s/o Lt Kedarnath Agarwal of M.R.Road ward no-VIII PS Siliguri Dist Darjeeling (vi) Harindar Chowrashiya-40yrs s/o Lt Shiv Prasad Chowrashiya of Sussuratanagar NBMC & (H) PS Matigara Dist Darjeeling (vii) Md Sakil -20yrs s/o Md Ali of Kholaibaktari Near Kali Mandir PS Matigara Dist Darjeeling along with all connecting paper.

I, SI Srimanta Chatterjee of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on performing Special mobile van duty against COVID-19 rules & guidelines. Myself along with ASI Aminul Islam, ASI Kalachand Singha, and force all of Khalpara TOP-II under Siliguri PS had been to Jhankar More, Siliguri at about 12 AM (Khalpara TOP GDE No- 98 dated 04.06.21) and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-629-1SS/2M-22/2020 dated 05.05.21 & Order No-647-1SS/2M-22/2020 dated 15.05.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID-19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.
