Sub: Pressure & Threat to withdraw the complaint

Respected Sir,

I, Tarannum Khatoon, w/o. Haider Ali, D/o. Kamruddin Hashmi, resident of TN Road, Sonada (near Rainbow Restaurant), presently residing at my Parental House i.e. Kajib Nagar, Siliguri.

My elder daughter i.e. Aisha Khatoon Hashmi has lodged a complaint vide case no 65/2021 r/w special POCSO case no 27/2021. dated 15/05/2021, at Siliguri women's Police Station against my husband. Before she lodged this complaint we were receiving threats and were going through a highly pressurised condition by some local people of Sonada, my brother-in-law Adam Ali & Ahmed Hussain, Uncle-in-law Noor Hasan, MD. Kamrul Huda (Imam of Sonada) to not to lodge a complaint against my husband Haider Ali.

So somehow we escaped ourselves from Sonada and took shelter in my parental house & lodged the F.I.R. at Siliguri women's Police Station. From then we have received many phone calls from MD. Kamrul Huda (Ph No. 8967880286), S/o. MD. Kameluddin, Imam of Sonad Masjid, resident of Munda Hata, P.S. + P.O. Sonada, Dist.

Darjeeling, Pin-734209 to my brother and fathers

one i.e. 7001545417 of Shohid Swam (brother) and 7001054334 of Kamroddin Hashmi (father) respectively. Over these phone calls he is repeatedly creating pressure onto us to withdraw the aforesaid complaint and to compromise the allegations. Because, due to our complaint, we have become the reason of infamy of whole community. And also threatened us if we don't do the same then they will would excommunicate or outcaste all of us. As they are very much powerful and influential and we are nothing to them, they can do anything and for that we are feeling very much afraid of this.

I went to Siliguri Women's Police Station to lodge this complaint but they refused to receive this complaint for any unknown reason, so I am filing this complaint to your good office to attract your attention in this regard and please do the needful.
