Sir,

In producing here with one accused person namely Gouranga Mandal (Male/ 48 Yrs), S/O Lt Mahadeb Mandal, of - Ranidanga Bazar, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling and the following articles under seizure:-

(1) 23 (Twenty three) Bottles of 60 up Himalayan Gold Country spirit each contain 600 ML and Rs. 100/- (One Hundred) only. Total value Rs. 2300/- (Twenty three hundred) only.

I ASI Prem Bhakta Mallick of NBMC OP lodged a written complaint against the accused person namely Gouranga Mandal (Male/ 48 Yrs), S/O Lt Mahadeb Mandal, of - Ranidanga Bazar, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling to the effect that, on 05.06.2021 as per order of O/C NBMC OP I along with force C/500 Mayaram Oraon, CV/665 Raju Sarkar & CV/920 Kamal Barman all are of NBMC OP with Govt. vehicle no WB74/8035 were holding raid against anti social elements, warrentees, ID liquor etc in different area under NBMC OP in course of which I received information from my source that one Gouranga Mandal stored a huge numbers of bottles liquor inside road side patty shop near Chathat Medical More and used to sell to the local youth in higher rates for his illegal monetary gain. I immediately informed O/C NBMC OP and as per his kind direction wasting no time I along with my accompanied party left for Chathat Medical More area to verify the veracity of information. On reaching at Chathat Medical More. But seeing us the source I held raid at the patty shop of Gouranga Mandal at Chathat Medical More. In the above noted accused person try to flee away from the spot, but we managed to apprehend him. I held through search in the patty shop of above noted accused person, in course of search I recovered the above noted bottles of liqure from inside his patty shop. I seized the above noted articles as alamat of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search, seizure and arrest were made in between 12.15 hrs to 12.45 hrs on 05.06.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Gouranga Mandal (Male/ 48 Yrs), S/O Lt Mahadeb Mandal, of - Ranidanga Bazar, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling and arrange for its investigation.
