Sir,

I, ASI. Subhnedu Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Mohan Chettri (47/M) S/O Lt. Om Bahadur Chhetri of Bidhan Pally, Kadamtala, PS- Matigara, Dist-Darjeeling under arrest along with following seized articles viz ; (I) 18 (Eighteen) bottles of Himalayan Gold Country Spirit each bottle containing 600ml.(total 600ml X 18=10.8Ltrs.) and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml, taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-A-1" (III) 10 (ten) bottles of Kingfisher Strong Premium Beer each bottle containing 650 ml.(total 650ml X 10=6.5 Ltrs.) and mark as Exhibit "B" (VI) 01(one) bottle of Kingfisher Strong Premium Beer containing 600ml. taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-B-1" (Grand total 10.800 + 6.500=17.3Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 05.06.2021 at 18.05 hrs received a secret source information that one person namely Mohan Chettri (47/M) S/O Lt. Om Bahadur Chettri of Bidhan Pally, Kadamtala, PS- Matigara, Dist-Darjeeling has stored huge quantity of Illicitly distilled liquor and country spirit at his at his house without any valid license. Diarized the matter vide Matigara PS GDE No.242 Dt.- 05.06.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with PSI Shekhar Adhikary, ASI Nitai Ch. Mondal, Const- 1035 Santosh Rabi das, Const- 1008 Kanak Roy, CV- 155 Sukumar Das left for Bidhan pally to verify the veracity of the source information. On reaching at the spot at 18:20 hrs it was found that huge quantity of Illicitly distilled liquor and Country Spirit stored in the house of Mohan Chettri who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Mohan Chettri. There after I called two independent witnesses of that locality namely i) Loknath Das(41/M), S/O-Lt. Sunil Das of Ramkrishna Pally, Paul Para, PS- Matigara, Dist-Darjeeling and ii) Md.Khalilur Rahaman(50), S/O-Lt. Hassan Ali of Tarijote, PO-New Rongia, PS- Matigara, Dist-Darjeeling and in the very presence of those witnesses I search the house and seized the above noted Illicitly distilled liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Mohan Chhetri. On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 05/06/21 in between 18:25 hrs to 18:45 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Mohan Chettri (47/M) S/O Lt. Om Bahadur Chettri of Bidhan Pally, Kadamtala, PS- Matigara, Dist-Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Mohan Chettri (47/M) S/O Lt. Om Bahadur Chettri of Bidhan Pally, Kadamtala, PS- Matigara, Dist-Darjeeling and arrange for its investigation.
