Sir,

In producing herewith the two (02) accused persons namely 1) Sanaj Sahani (28), S/O- Budhan Sahani of Rajendra nagar, Cooliepara, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling, 2) Pritam Paul (35), S/O- Lt Karuna Paul of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling of in custody and the following property under seizure, along with seizure list (i) 36 (thirty six) strips of SPASMO-PROXYVON PLUS capsules, containing each strips 08 capsules and marked as Exhibit-A, (Total Capsuls 288) (Batch No JU10678) (ii) 01(one) strips of SPASMO PROXYVON capsules, containing 08 capsules randomly taken from Exhibit-A for examination and marked as Exhibit-A-1 (iii) 270 (two hundred seventy) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and marked as Exhibit-B, (Total capsules 2160) (Batch NO SMC-20023), (iv) 01(one) strips of SIMPLEX C+ Capsule, containing 08 capsules randomly taken from Exhibit-B for examination and marked as Exhibit-B-1, (v) 432 (four hundred thirty two) strips of Winspasmo Forte Capsules, containing each strips 08 capsules and marked as Exhibit-C, (Total Capsuls 3456) (Batch No WPS19015), (vi) One (01) strips of Winspasmo Forte Capsules, containing each strips 08 capsules and marked as Exhibit-C, marked as Exhibit-C-1, (vii) One big size brown colour Catoon, in which the above noted articles were kept as per seizure list, (viii) One Black & red colour Bajaj Pulsar bearing Reg. No WB74AM-7329, in which the seized article was carried by the above noted accused persons. The above noted articles Seized as alamat of the case.

I, SI Samik Paul of Pradhannagar PS, SPC do hereby lodged this complaint to the effect that on 06.06.2021 at 22.10 hrs I received secret source information vide PDN P.S. GDE NO 312, Dated 06.06.2021, that two persons standing in front of SNT Bus stand with a Black & Red colour motor cycle is carrying huge quantity of illegal contraband drugs for selling the same at Siliguri area. I accordingly shared the information with you and according as per your kind direction at 22.15 hrs myself along with ASI Debasis Das, ASI Ratan Pradhan, ASI Ashit Singha, CV 131 Ranjan Sharma, CV 128 Ajay Kr Sahani, CV 992 Jagadish Roy took departure for SNT Bus stand vide PDN P.S. GDE NO 313, MCC No 1457, Dated 06.06.2021, we reached at the spot at 22.30 hrs and then I called two disinterested witnesses namely (1) Sahadeb Mahato (32), S/O- Lt Ramjee Mahato of SNT Bus stand, PS Pradhannagar Dist- Darjeeling, 2) Sanjib Kumar (32), S/O- Lt Biswambar Kamti of do from that place. Accordingly after being confirmed by source I apprehended the accused persons with one Black & red colour motor cycle which carrying a big size cartoon. After disclosing out our identity they disclosed their identity as 1) Sanaj Sahani (28), S/O- Budhan Sahani of Rajendra nagar, Cooliepara, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling, 2) Pritam Paul (35), S/O- Lt Karuna Paul of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling. Then I gave him the option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a gazette officer and I also gave him a written information in this regard and read it out the same and he give consent verbally.

Consequently I contacted to the Sri Subasisi Chaki, I/C Pradhannagar PS SPC for come to the spot and supervise the entire process of search and seizure. Sri Subasisi Chaki, I/C PS SPC arrived at the spot at 22.45 hrs, thereafter the process of the search was started. Before conducting search self search of me and Sri Subasisi Chaki, I/C Pradhannagar PS SPC had been conducted by



the detained person and a memo had been given to him to the effect that and he could not find any other offending things except arms and IO kit and weighing machine. On search the big size cartoon from the joint possession of the apprehended accused persons I recovered (i) 36 (thirty six) strips of SPASMO-PROXYVON PLUS capsules, containing each strips 08 capsules and marked as Exhibit-A, (Total Capsuls 288) (ii) 01(one) strips of SPASMO PROXYVON capsules, containing 08 capsules randomly taken from Exhibit-A for examination and marked as Exhibit-A-1 (iii) 270 (two hundred seventy) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and marked as Exhibit-B, (Total capsules 2160), (iv) 01(one) strips of SIMPLEX C+ Capsule, containing 08 capsules randomly taken from Exhibit-B for examination and marked as Exhibit-B-1, (v) 432 (four hundred thirty two) strips of Winspasmo Forte Capsules, containing each strips 08 capsules and marked as Exhibit-C, (Total Capsuls 3456), (vi) One (01) strips of Winspasmo Forte Capsules, containing each strips 08 capsules and marked as Exhibit-C, marked as Exhibit-C-1, (vii) One big size brown colour Catoon, in which the above noted articles were kept as per seizure list, (viii) One Black & red colour Bajaj Pulsar bearing Reg. No WB74AM-7329, in which the seized article was carried by the accused Pritam Paul whereas Sanaj Sahani was seated on the driving seat of the said motor cycle. On demand the apprehended persons were failed to produce any document in respect of the recovered contraband drugs or in respect of the vehicle. Accordingly as per kind instruction, and in presence of the independent witnesses, I seized the above noted articles, under proper seizure list. The seizure has made between 22.55 hrs to 23.35 hrs. Accordingly at 23.40 hrs I arrested the accused persons namely 1) Sanaj Sahani (28), S/O- Budhan Sahani of Rajendra nagar, Cooliepara, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling, 2) Pritam Paul (35), S/O- Lt Karuna Paul of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling, issuing proper memo of arrest. At 23.55 hrs myself along with force with arrested accused persons and seized article brought to Pradhan nagar Police station.

Hence it is prayed that a specific case may kindly be started against the accused persons namely 1) Sanaj Sahani (28), S/O- Budhan Sahani of Rajendra nagar, Cooliepara, W/No-1, P.S. Pradhan nagar, Dist- Darjeeling, 2) Pritam Paul (35), S/O- Lt Karuna Paul of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling as per law.
