In producing herewith the arrested accused person namely (1) Safi Mophammad(37yrs) s/o Late Jabbar Khan of Alipur, Tigra(80), Mewat, PO-Hirwari, PS-Firojpur Jelka, Dist-Nuh, Haryana along with the seized (1) Vehicle No. RJ02GB-6251(Articulated Vehicle) loaded with Stone Chips, I beg to submit that tonight on 06/07.06.2021 at 01.45 hrs in course of my Naka duty at Gossainpur, More, vide GDE No. 258 dtd 06.06.2021 and MCC.
