Sir,

In producing herewith the arrested accused person namely (1) Safi Mophammad(37yrs) s/o Late Jabbar Khan of Alipur, Tigra(80), Mewat, PO-Hirwari, PS-Firojpur Jelka, Dist-Nuh, Haryana along with the seized (1) Vehicle No. RJ02GB-6251(Articulated Vehicle) loaded with Stone Chips, I beg to submit that tonight on 06/07.06.2021 at 01.45 hrs in course of my Naka duty at Gossainpur, More, vide GDE No. 258 dtd 06.06.2021 and MCC. No. 1435 dtd 06.06.2021, I ASI Asish Karmakar alongwith C/1107 Pradip Roy and CV520 Bhagaban Singha, detained the said Vehicle was coming towards Bagdogra Bihar More from Matigara side and on searching the said vehicle was found loaded with Stone Chips. On demand, the accused person Safi Mophammad, the driver of Vehicle No. RJ02GB-6251 failed to produce any valid documents or license in support of him for lifting and transportation of the same. So, there is sufficient ground to believe that the said loaded stone chips were taken either theft or any other fraudulent means and for which, I seized the Vehicle No. RJ02GB-6251 loaded with Stone Chips under proper seizure list maintaining all formalities, the seizure process was made in between 01.55 hrs to 02.10 hrs and subsequently arrested the said accused person Safi Mophammad observing all formalities and narrated him the ground of his arrest.

During interrogation, he confessed his guilt that he was carrying the Stone Chips loaded in said Vehicle being lifted from Matigara side for illegal gain without any valid document.

Under the above circumstances, I pray to your honour that a specific case under proper section of law, may kindly be registered against (1) Safi Mophammad(37yrs) s/o Late Jabbar Khan of Alipur, Tigra(80), Mewat, PO-Hirwari, PS-Firojpur Jelka, Dist-Nuh, Haryana the driver of Vehicle No. RJ02GB-6251 and arrange for its investigation.


