Sir,

In producing herewith one arrested accused person namely Surojit Saha (M/32) S/O- Lt. Ananda Mohan Saha of Vidya Chakra Colony, W/No. 44, PS-Bhaktinagar, Dist- Jalpaiguri along with seized articles 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each in a nylon bag which was used for carrying the seized articles SL. N- 1.

I, SI Rana Brahma of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that today on 05/06/2021 at 08.25 hrs during morning mobile van duty I received a secret source information that one person is carrying huge quantity of country spirit through Sevoke road, towards Vidya Chakra Colony. Accordingly I informed the information to O.C Panitanki TOP and as per his direction I along with, ASI Surajit Mallick, C/114 Naresh Hasda, CV-1007 Jiten Roy, left for PO to work out the information. On arrival at Sevoke Road near M Bazar at 08.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Vidya Chakra Colony and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each with Nylon Bag which was used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 09.10 hrs to 09.25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs.1900/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Surojit Saha (M/32) S/O- Lt. Ananda Mohan Saha of Vidya Chakra Colony, W/No. 44, PS-Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
