Accordingly I seized 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each with Nylon Bag which was used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 09.10 hrs to 09.25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs.1900/-
