Sir,

In producing herewith one arrested accused person namely Kamal Lama (Male/59) S/O-Lt Inju Lama of- Subhashpally, Bagrakote, Jail Road, Wad No 18, PS Siliguri, Darjeeling along with seized articles (1) 22 (Twenty two) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1.

I, SI Prabhash Saha of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that today on 05.06.2021 at 09:05 hrs received secret source information that one person is carrying huge quantity of bottle country spirit through Sevoke Road, near post office towards Subhashpally, Bagrakote, Siliguri. Accordingly informed to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 121 dated 05.06.21 and thereafter as per his direction I along with, ASI Biswajit Ghosh, ASI Mantu Dey, C/153 Santosh Mahato, CV/1009 Manoj Thakur, left Panitanki TOP vide Panitanki TOP GDE No- 122 Dt-05.06.2021 at 09:10 hrs to work out the information. On arrival at Sevoke road, near post office, Siliguri at 09:20 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses. On interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Subhashpally, Bagrakote, adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 22 (Twenty two) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- and 01 (One) Nylon Bag which used for carrying the seized articles SL. No- 1, under proper seizure list and labeled the same in presence of witnesses and duly sign by witnesses and also by the accused person. The seizure was made between 09:35 hrs to 09:55 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.2200/-

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Kamal Lama (Male/59) S/O-Lt Inju Lama of- Subhashpally, Bagrakote, Jail Road, Wad No 18, PS Siliguri, Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
