In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Jitendra Kumar Prasad (42yrs) S/O- Lt. Pares Nath Prasad of Bikash Nagar, Salugar, Ward No-42, PS- Bhaktinagar, Dist-Jalpaiguri, (ii) Pankaj Guha (26yrs) S/O- Basudev Guha of Ambika Nagar, near Ambika Nagar Sporting Club, PS-NJP, Dist-Jalpaiguri, (iii) Biki Paswan (34yrs) S/O- Hiralal Paswan of D.S. Colony, near Kali Mandir, Ward No-34, PS-NJP, Dist-Jalpaiguri, (iv) Ratan Roy (50yrs) S/O- Lt. Suren Roy of Tikiapara, near Kalimandir, Ward No-28, PS-Siliguri, Dist-Darjeeling, (v) Mona Saha (35yrs) S/O- Ashim Saha of Tikiapara, near Kali Mandir, Ward No-28, PS-Siliguri, Dist-Darjeeling and (vi) Sunil Kumar Mahato (26yrs) S/O- Suresh Mahato of Tikiapara, Ward No-28, PS-Siliguri, Dist-Darjeeling alongwith one Toto red colour, bearing No- WB 71TC/873. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge this complaint against the above noted arrested persons to the effect that, on 05.06.2021 at 17.35 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. One of them namely Biki Paswan was roaming there with his TOTO.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
