Sir,

With due respect and humble submission I beg to report that myself along with ASI Kalachand Singha and force with lady police personals while performing Spl raid duty (This refers to Khalpara TOP GDE No-140 dated 05.06.21) and at about 17.20hrs received an information from source that one lady namely Sushila Sahani w/o Nagendar Sahani of Maharaj Colony, ward no-IV, PS Siliguri Dist Darjeeling has gathered huge quantity of liquor in her house at Maharaj colony ward no-IV for selling the same in the open market for her wrongful gain. Inform the matter over telephone to you. As per your kind instruction held raid in the house of above noted lady in presence of witnesses and lady Police personal and recovered (1) 15 (Fifteen) bottles of Himalayan Gold 60up country spirit each bottle containing 600 ML & each mentioning MRP Rs-100/ total 1500/ from her house the above noted articles from her house. Seeing the police the above noted lady fled away from the spot. I seized the above noted articles from her house after preparing proper seizure list. (The seizure was made in between 17.25 hrs to 18.10 hrs)

During enquiry it came to learn that the above noted lady is selling the liquor in open market since long for her wrongful gain. Local people are very much annoyed upon her.

I therefore request you a specific case may kindly be started against the accused Sushila Sahani w/o Nagendar Sahani of Maharaj Colony, ward no-IV, PS Siliguri Dist Darjeeling under proper section of law and arrange for investigation..
