Sir,

In producing herewith arrested accused person namely Paresh Das (50) S/O Late Panchanan Das of Rabindra Nagar, Godadhar Sarani, Ward No. 21, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 24 (twenty four) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amount of 24x Rs 100/- =RS.2400/-) ii) 10 (Ten) sealed pouch Officer's Choice Deluxe Whisky containing 180 ml each manufactured by allied blenders and distillers Pvt. Ltd, Kallyani Industrial Growth Centre (Amount of 10 x Rs 140/- =RS.1400/-) and 3) 08 sealed bottles of Royal Lancer whiskey containing 180 ml each (Amount of 08 x Rs 93/- =RS. 744 /-) as per seizure list.

I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Paresh Das (50) S/O Late Panchanan Das of Rabindra Nagar, Godadhar Sarani, Ward No. 21, PS- Siliguri, Dist- Darjeeling to the effect that on 05.06.21 at 20.05 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Rabindra Nagar, Godadhar Sarani under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 312 dated 05.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Siben Sarkar, ASI Subir Sen, CV/622 Ramanath Barman and CV-283 Prosenjit Dey left for Rabindra Nagar, Godadhar Sarani under Siliguri PS vide Siliguri P.S GDE NO: 313 to verify the veracity of the information. On reaching at 20.35 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching we found i) 24 (twenty four) sealed bottles of

Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amount of 24x Rs 100/- =RS.2400/-) ii) 10 (Ten) sealed pouch Officer's Choice Deluxe Whisky containing 180 ml each manufactured by allied blenders and distillers Pvt. Ltd, Kallyani Industrial Growth Centre (Amount of 10 x Rs 140/- =RS.1400/-) and 3) 08 sealed bottles of Royal Lancer whiskey containing 180 ml each (Amount of 08 x Rs 93/- =RS. 744 /-) which was kept concealed in his house. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20.45 hrs to 21.25 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules for selling the said country made sprit without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Paresh Das (50) S/O Late Panchanan Das of Rabindra Nagar, Godadhar Sarani, Ward No. 21, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigate.
