In producing herewith 02 (Two) arrested accused persons U/s 41 Cr.P.C who disclosed their identity as (1) Chayan Dutta (41) S/O Late Debesh Chandra Dutta of Michael Mahasudhan Colony ,PS New Jalpaiguri ,Dist. Jalpaiguri (2) Bideshi Sahani(43) S/O Late Vikari Sahani of Railway Hospital More, PS NJP, Dist. Jalpaiguri.

I, ASI Bhai Chandra Tamang of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that on 03/06/21 while on performing evening mobile Van duty in c/w NJP vide GDE No 114 Dtd. 03/06/21 and MCC NO 1398/21 Dtd. 03/06/21 I, along with forces had been to Gora More area , in between and in between 20:15 hrs and 21:05 Hrs, and found that the above noted persons are gathered there without any reason and found them without wearing mask also making unnecessary gathering at Gora more area. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 20:15 hrs and 21:05 Hrs, duly signed by them in presence of witnesses inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
