Sir,  
With due respect, I am producing herewith the arrested accused person namely Mithun Das (39 years) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No-35, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 36 (Thirty Six) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of MRP Rs 100/- of each bottle.
2. 06 (Six) bottles of TUBORG premium Beer containing 650 ML in each bottle of MRP Rs 141/- of each bottle.
3. 03 (Three) numbers of paper made pouch of Officer Choice Deluxe Whisky containing 180 ml in each pouch of MRP Rs 140/- in each pouch.
4. 04 (Four) bottles of Mc Dowell's No-1 Celebration Mature Rum containing 180 ML in each bottle of MRP Rs 153/- of each bottle.
5. 02 (two) bottles of Royal Stag Blanded Whisky containing 180 ml in each bottle of MRP Rs 235/- each bottle.

I beg to state that today i.e. on 05.06.21 at 07.05 hrs I received a secret source information that one person named Mithun Das of Bhakti nagar Pipe line is selling ID liquor at his hotel styled as Ganesh Hotel situated at IOC Gate, PS- NJP, Dist.- Jalpaiguri for his wrongful gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 190 dated 05.06.21 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Paresh Rava, CV/824 Niru Yadav, CV/116 Rohit Mahato left for IOC Gate to work out the information in hand. At about 07.25 hrs we arrived at Ganesh Hotel and being shown and identified by the source we managed to intercepted one person who disclosed his name and identity as Mithun Das (39 years) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No-35, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling ID liquor at his hotel for his illegal gain. On search the above noted ID liquor found at his hotel. On demand he failed to produce any valid documents in respect of ID liquors found at his hotel. Accordingly I arrested the above noted accused Mithun Das (39 years) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No-35, PS- NJP, Dist.- Jalpaiguri under proper memo of arrest and observing all the formalities of arrest and seized the above noted I/D liquor from the possession of accd Mithun Das under proper seizure list. The whole process of search seizure & arrest was made in between 07.45 to 08.45 hrs on 05.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mithun Das (39 years) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No-35, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
